The regular meeting of the Cerro Gordo CUSD #100 Board of Education was called to order by President Miller at 6:21 p.m. Members Bebar, Callaway, Curran, Howell, Miller, and Runyen answered roll call. Also present was Superintendent Weidner. Member Greenwood was absent.

The FY26 Amended School District Budget Hearing was held. No questions were raised by members of the audience.

- Recommendation to update Cerro Gordo Elementary School activity fund, removing Stacey Wildman and adding Denise Williams
- Recommendation to authorize spending between July 1, 2026 and adoption of FY27 budget
- Recommendation to authorize application for state and federal grants including 3 Circles Grant
- Recommendation to approve Prairie State Insurance Cooperative Renewal

Superintendent Weidner reported she completed principal evaluator training on June 8th and June 9th, and WIDA training for multilingual students; Dr. Weidner participated in a radio interview with Seth Laurence, attended board meetings for HTA, MPSPED, and the ROE; attended the Piatt Co. Agencies meeting on June 2nd, and a superintendent's roundtable with State Representative Regan Deering on June 4th; the ROE compliance visit took place on May 20th; the track respray and repainting project and the playground reseal are both complete; the masonry repair and exterior resealing project at both schools started June 15th and should finish before the start of the new school year; Veregy's initial report was presented on June 2nd and they will provide the district a more detailed proposal in August or September; the district received four FOIA requests from Data Branch on May 28th, June 3rd, June 7th, and June 12th..

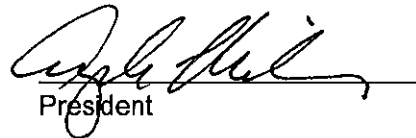
