Superintendent Weidner reported the district was one of 49 applicants for the Heart of Illinois Foundation Community Works Grant and was chosen to receive \$15,000 for the grant titled "Fired Up for the Arts" and the money will be used to purchase a kiln for the art program; the district was recognized at a Workforce Roundtable Meeting for the willingness to allow Senior students to participate in activities that work on resumes, interview skills, and job seeking (students were featured in a commercial for the Decatur Chamber of Commerce that has been airing on WAND television station); Dr. Weidner participated in a promotional video for Kings Financial regarding the construction and related bond issues that the district has completed over the past few years; a chair lift has been installed in the annex at the elementary school; replacement slides will be installed on the elementary playground.
